

① CERTIFICATION LEVELS

The level of certification is indicated here and also by the background header colour^a.

There are four levels of certification in the CraneSafe program. For a full description of each level of certification, please consult with WorkSafeBC's partner agency responsible for crane operator certification in BC, British Columbia Crane Safety (BCCS) at www.bccranesafety.ca.

② CERTIFICATE NUMBER

Each certificate is issued with a unique number that can be referenced by Fulford Certification and BC Crane Safety.^b

③ CRANE TYPE

The type of crane, along with any restrictions^c, is listed here. See the Crane Hierarchy table at www.fulford.ca for the types of cranes the operator is permitted to operate.

④ OPERATOR NAME

The operator name is listed last name first (in CAPS) followed by first name and any initials.

⑤ DATE OF ASSESSMENT/EXPIRY/ISSUE ASSESSMENT: Date the operator successfully completed all components of the CraneSafe assessment.

EXPIRY: Level B – Date the certificate expires.^d

ISSUE: The certificate is valid from this date (only for this employer at the worksite).

Levels C and D: the date the certificate was issued.

⑥ ADDRESS

The operator's home address at the time the certificate was issued.

⑦ BACKGROUND & HOLOGRAM

The BC CraneSafe Certificate appears with the words British Columbia in the background.

The card is laminated with holograms interspersed.

⑧ LOGOS

The WorkSafeBC logo appears with the "Certified" stamp on the top left corner. The CraneSafe logo is on the bottom lefthand corner.

⑨ PHOTO

This is a colour photo of the operator at the time of assessment. The operator should appear without sunglasses or headgear.

⑩ EMPLOYER & WORKSITE

The Level D certificate lists the name of the employer as well as the worksite address (as this is the only location the certificate is valid).

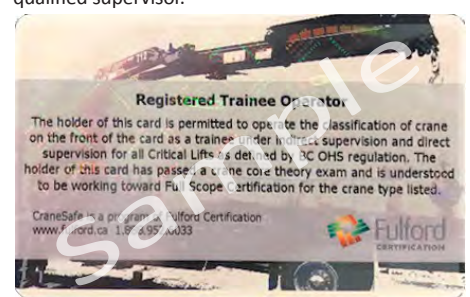
Level A – Full Scope Crane Operator

The highest level of certification — achieved by successful completion of the CraneSafe Certification assessment.



Level B – Provisional Crane Operator

Held by registered Apprentices and Trainee crane operators formally engaged in a workplace training program.



Operators must be supervised indirectly at all times by a qualified supervisor. Critical lifts may be performed only under the direct supervision of a qualified supervisor.

Level D – Limited Scope Operator

Held by employers on behalf of the employee — not transferable between worksites or employers. Operator may only operate the type(s) of crane(s) indicated on the card.

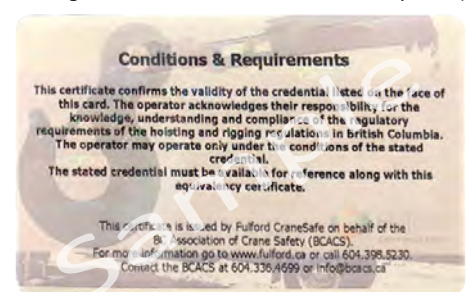


Employer must be prepared to provide evidence of training (successful completion of an in-house competency certification program at the worksite indicated on the card). No critical lifts permitted.

BC Equivalency for Crane Operator



No longer issued as a wallet card as of January 2018.)



- a. Level A: olive green for incumbent crane operators; yellow/olive green for non-incumbents
Level B: orange
Level D: teal
- b. Incumbent operators (those who registered with the BCACS by 31 July 2007) are indicated by an "I".
- c. Restrictions can include a maximum capacity (e.g. 10 tonnes) or maximum boom length (e.g. 60 feet).
- d. The Level B certificate is valid for one year from the original date of issue. It is renewable by application for an additional 12 months (ITA trades may renew up to three times for a total of 4 years; non-ITA trades may renew one time only).
