

This application is for Level D Crane Operators who are changing worksites and/or employer. They are not required to rewrite the BC Crane Operator Core Theory Exam.

Level D Crane Operation

1. Level D Limited Scope Certification permits operators to operate any crane(s) for which they have successfully completed an in-house competency certification program at the worksite indicated on page 2.
2. The Level D Limited Scope Certificate is held by the employer on behalf of the employee and is not transferable between worksites or employers.

Should the Level D crane operator leave the employ of the employer named on the Level D Certificate, the Certificate is invalidated.
3. No critical lifts (as defined by WorkSafeBC) are permitted.
4. The employer must be prepared to show evidence that the operator has received training for the specified crane(s) operated. This can include:
 - an Employer’s Record of Training for Level D Certified Crane Operator;
 - BCACS electronic logbook;
 - purchased training materials;
 - confirmation of training by a designated instructor; etc.
