

1. Level D Limited Scope Certification permits operators to operate any crane(s) within the crane type category for which they have successfully completed an in-house competency certification program at the worksite indicated on page 2.
2. A successful result on the Level D BC Crane Operator Core Theory Exam (an online multiple choice test) is required for certification.
3. The Level D Limited Scope Certificate is held by the employer on behalf of the employee and is not transferable between worksites or employers. Should the Level D crane operator leave the employ of the employer named on the Level D Certificate, the Certificate is invalidated. The operator may apply for a Revised Certificate with a new employer.
4. No critical lifts (as defined by WorkSafeBC) are permitted.
5. The employer must be prepared to show evidence that the operator has received training for the specified crane(s) operated. This can include:
 - an Employer's Record of Training for Level D Certified Crane Operator;
 - BC Crane Safety electronic logbook;
 - purchased training materials;
 - confirmation of training by a designated instructor; etc.
6. A list of crane operator competencies is available online at www.fulford.ca (see crane type).

3. NOTE:

- a. You have **30 days** from the day you are registered in the online test to complete it. After 30 days, you will forfeit your application fee and will need to reapply.
- b. The online exam may be attempted a total of three times. For a second or third attempt, the Re-Application form must be submitted to Fulford.

No hats or sunglasses to be worn. Include the head and shoulders. Photos must be taken within the past 12 months.
