3. Results from the Practical Assessment will be sent to the Qualification Certificate program coordinator.
4. The crane you will be assessed on must have up-to-date certification and the Load Chart and Log Book must be available or the assessment will not take place.
5. Space must be available to write the Load Chart & Rigging segment of the assessment. The person being assessed must have privacy.
6. Outrigger pads must be available for crane set up. The floats provided with the cranes are not sufficient.
7. Adequate yard space must be available for crane set up and to perform the operating components of the assessment.
8. No power lines may be in the operating area.
