Wallet & Digital Cards

Fulford Certification issues certification credentials for rigging training and assessment. Fulford is transitioning from issuing wallet cards to digital cards for all three levels of rigging certification. Both wallet cards and digital cards are valid proof of rigging certification.

- Digital cards will be issued for all rigging training as of 28 July 2025. Cards are compatible with both Apple and Android mobile devices.
- Previously issued wallet cards remain valid until their expiry date and will be converted to digital cards upon renewal.

Certification Levels

There are three levels of certification in the Fulford rigging program. The level of certification is indicated at the top of the wallet card and can also be identified by the background colour. For a full description of each level of certification, please consult the Fulford website www.fulford.ca/rigger-certification.

Level 1 – Rigging Fundamentals

is the entry level for rigging training.

Participants receive either a Certificate of Completion or a Certificate of Competence.

- Certificate of Completion is valid for 3 years.
- Certificate of Competence includes one-on-one assessment with feedback on the participant's skills.
 Valid for 5 years.

Level 2 – Advanced Rigger

takes rigging skills to the next level.

Participants must have already completed Level 1 Rigging Fundamentals or equivalent.

Participants receive either a Certificate of Completion or a Certificate of Competence.

- Certificate of Completion is valid for 3 years.
- Certificate of Competence includes one-on-one assessment with feedback on the participant's skills.
 Valid for 5 years.

Level 3 – Load Turning & Drifting

is intended for riggers to develop more specialised skills.

Participants must have already completed Level 1 Rigging Fundamentals or equivalent.

Participants receive either a Certificate of Completion or a Certificate of Competence.

- Certificate of Completion is valid for 3 years.
- Certificate of Competence includes one-on-one assessment with feedback on the participant's skills.
 Valid for 5 years.

Issue & Expiry Dates

Date of Issue

The date the card is issued to the rigger after successfully completed the Fulford training and orientation session and one-on-one assessment for the Certificate of Competence.

Date of Expiry

The date the certificate expires. Certificates of Completion are valid for 3 years. Certificates of Competence are valid for 5 years.

Digital Card Features

 Each digital card has a unique digital code which is featured on the front of the digital card in both number format and in a black and white matrix.

Online Verification

- Digital cards can be verified by accessing the online verification website to confirm the status of rigger certification.
- Use the unique QR code or certification number printed on the digital card to access the site (or scan the code using a mobile devce.
- The rigger's photo will appear here as well as all other applicable information.

Apple versus Android

- Digital cards are available in Apple and Android versions.
- Both cards display the First Name and Last Name of the rigger, Date of Issue and/or Expiry as well as the Level of Certification.
- Apple cards display a photo of the rigger.
