- Self Erect Tower Crane
- 1. Trainee crane operators may renew their Level B certification for a period of 12 months one time only.
- 2. Operators must also submit their completed Level A application with this form.
- 3. It is expected that after two year's as a trainee an operator will be able to demonstrate competence on the CraneSafe assessment. If special circumstances require a second renewal then this will be granted only for a period of 6 months.

NOTE

- The renewal is valid for the **same crane type** as the original certificate.
- All operational restrictions continue to apply to the renewed Level B certification.
- The Level A Full Scope Application Form required with this application form is non-refundable.
